Director Omundson reminded everyone that the council focuses on a systems-level approach, and that she, as Administrative Director of the Courts, and Miren Unsworth from the Idaho Department of Health and Welfare are co-chairs. Miren Unsworth is leaving the council, as the Department of Health and Welfare has a new director, Alex Adams. Director Adams has assigned Jared Larsen to be the new co-chair for the council representing DHW. Jared is new to DHW but has been involved in the IBHC since its inception. | Director Dowell moved to approve the meeting minutes from 1/12/24 and 4/12/24. Judge Petty seconded the motion. No discussion. Motion passed by unanimous voice vote. |

The survey was widely distributed to over 1,000 professionals and received a 19% response rate.</p> <p>The survey asked a range of questions about hearings, services, and engagement, but Ms. Vance’s presentation covered selected results applicable to the IBHC.</p> <p>Most important resources for home safety (up to 5 selections)</p> <ul style="list-style-type: none"> - Substance Abuse Treatment - 85% - Mental Health Treatment - 84% - Low-Income Housing/Rental Assistance - 72% - Parenting classes - 57% - In-home support services - 54% <p>Barriers to providing services to keep children safely at home (one or more selections)</p> <ul style="list-style-type: none"> - Services not available in the community - 72% - Complex family needs - 64% - Financial resources of the family - 60% - Waiting lists - 59% <p>Resources to increase parent engagement</p> <ul style="list-style-type: none"> - Text notification - 75% - Transportation 63% - Printed resources about their role in the court - 37% <p>From the survey, they identified resources the court could easily address, like text notifications. Ms. Vance is also creating a parent mentor class and handbook to guide parents through the court process. | 5 | 1:25 p.m. | 60 min | Fiscal Year 2026 Opioid Settlement Fund Prioritization Action Item: Vote on recommendations for FY2026 Opioid | Co-Chairs | Director Omundson talked about the council’s role in Idaho Code 57-825 to make recommendations to the Governor and JFAC for the state’s portion of the opioid settlement fund (40%). She reminded the council that their role is to set high level priorities. | Originally, members were |

| | | | Settlement Fund Expenditures | | <p>After the priorities are set, then the Governor’s office, state agencies, and Legislature determine how the funds are put in agency budgets.</p> <p>Cheryl Foster reviewed the projects that are funded for the upcoming year from the opioid settlement fund. The council voted on these priorities in August 2023, and the amounts of funding reflect the order of priority. The top priority was workforce development. Then treatment, recovery, and prevention were tied for the next priority. The specific projects were selected from those submitted during the public comment process. The total funding exceeds \$2 million.</p> <p>Ross Edmunds noted that the council prioritized recovery, but the state used Millennium Funds to fund the community recovery centers instead of opioid settlement funds. (Due to Idaho Attorney General opinion limiting opioid funding to opioid-specific recovery.)</p> <p>The co-chairs and Cheryl categorized all the proposals submitted from the public comment process into voting categories. Director Omundson asked the members their opinion on the categories, and they found them acceptable.</p> <p>Dr. Pate asked whether we have effectiveness data on the currently funded projects to inform future investments. Director Omundson answered that we do not at this time but should review in the future. Ms. Foster noted that previously funded projects have been resubmitted for future funding.</p> <p>Director Omundson asked the members for open discussion: Senator Rabe - Lauded the reentry housing provided by IDOC and advocated for the housing-first model. Dave Jeppesen - Advocated for increasing workforce professionals to decrease the shortage of services Bree Derrick - IDOC requested funding for treatment for individuals in community reentry centers, as well as to expand other treatment offerings. Some courts are interpreting MOUD as an ADA accommodation, so the request hopes to avoid future litigation. They also want to mitigate the high number of people on supervision who are overdosing in the community.</p> | <p>directed to limit voting for their top three categories. | | | | | | <p>Ross Edmunds - Stated the biggest challenge is workforce. Also, housing is always an issue, as well as access to treatment. One example on the importance of housing is that it is difficult for someone to get sober when the only place available for them to stay is with their former dealer.</p> <p>Judge Gene Petty - Prevention is critical to avoid downstream effects, such as SUD.</p> <p>Director Dowell - Funding spent on prevention is a force multiplier for the money saved later on.</p> <p>Ross Edmunds - Prevention can also be keeping people from moving deeper into the system.</p> <p>Commissioner Brent Mendenhall - Noted supportive services are important to the issues related in Ms. Vance's earlier presentation.</p> <p>Deputy Director Miren Unsworth - Noted that there were some proposals for training health care providers on non-opioid pain management. Cheryl categorized them as "professional development for health care providers," but they could also fall under the prevention category.</p> <p>Members were directed to an online survey where they could select their top priorities. It will be an in-person all day meeting for all of the workgroups to work interdependently.
